
Canadian Intellectual Property Office

The share of the intangible asset market value has increased considerably.


COMPONENTS of S&P 500 MARKET VALUE






International IP Filing Trends

Patent filings for unique inventions exceeded 2 million in 2018




An estimated 13.4 million trademark applications were filed worldwide in 2020




IP Filing Trends in Canada

Growth in Standard Essential Patents (SEP)


Annual average growth rate of 16.4%





China is the leader with 6,344 SEP inventions





Number of SEP Inventions by Standard Setting Organization



Leading SEP Filing Institutions


Top Ten Institutions Worldwide between 1990 and 2018
